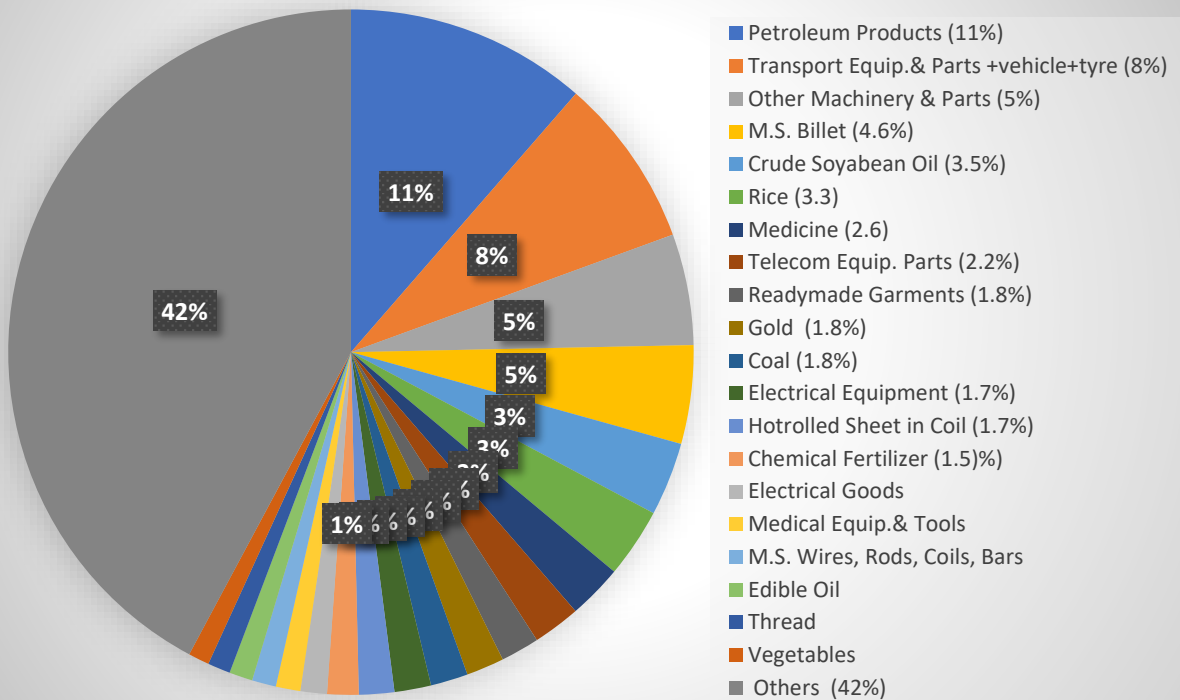

Imports of Major Commodities of Nepal in 2020/21

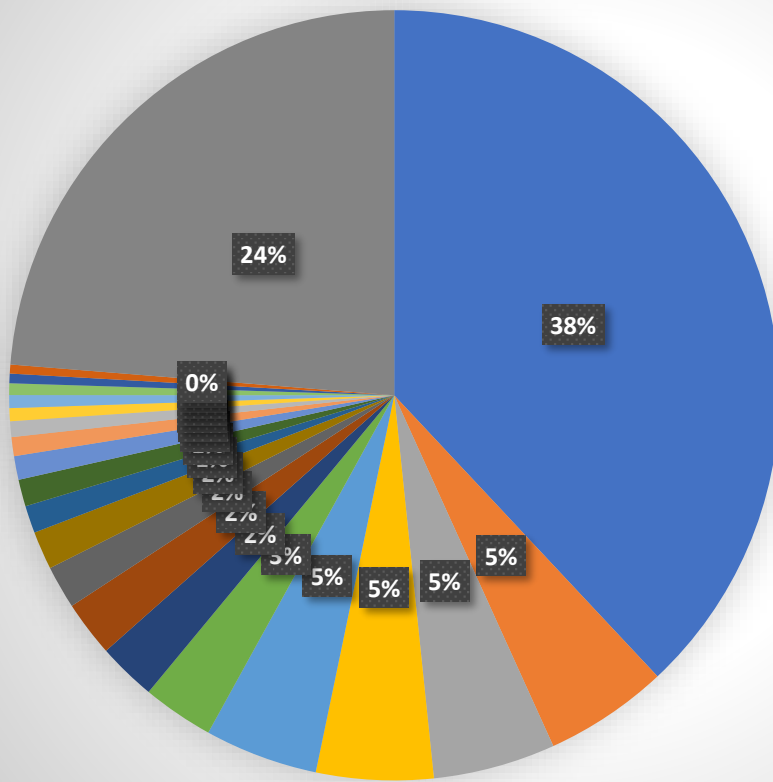
